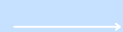
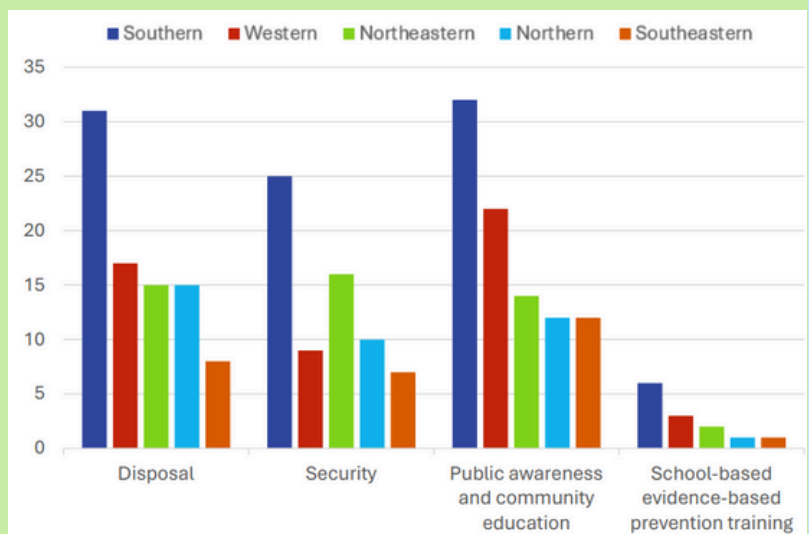

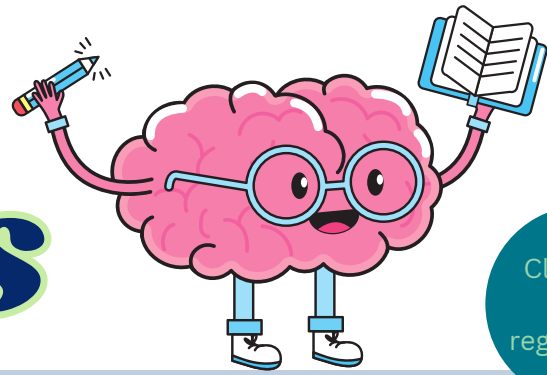
State Opioid Response Prevention (SOR-3) Mid-Year Program Progress Report

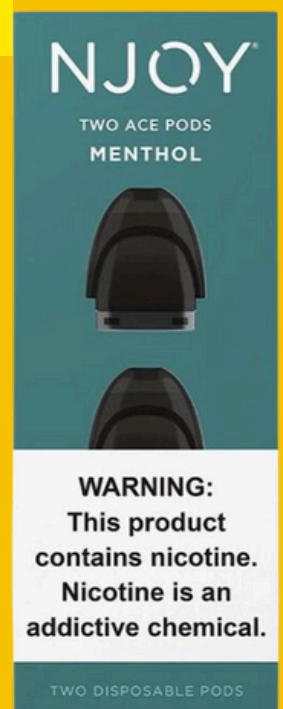
